For each request only for transaction information, or for both account opening and transaction information, a handling fee and computer processing fee of TWD 500 is charged per request per individual.</p> <p>3. A request made in person by an applicant who is 65 years old or above for the applicant's own account opening or transaction information to the TWSE is free of charge.</p> <p>4.
