## Notification of and Consent to the Collection, Processing and Use of Personal Data

  - (2)Area: Internal transmission within the territory of the R.O.C. and as required by laws and regulations
  - (3)Target: the personal data will be used by us or furnished in accordance with laws and regulations to the our competent authority or other third persons
  - (4)Way: We will collect, process, and use your personal data digitally or in paper form
