An administrator (to be elected by the family council or appointed by the court) or executor (to be appointed by the testator or by a person engaged by the testator, or elected by the family council or appointed by the court) shall submit:             <ol style="list-style-type: none"> <li>(1) Original Household Certificate or original Household Registration Cancellation document etc. with a note proving the death of the decedent.</li> <li>(2) Administrator: Original written evidence of election by the family council or appointment by the court.</li> <li>(3) Executor: Original written evidence of appointment by the testator or a person engaged by the testator, or election by the family council or appointment by the court.</li> </ol> </li> <li>2. The heir shall submit:             <ol style="list-style-type: none"> <li>(1) Original Household Certificate or original Household Registration Cancellation document with a note proving the death of the decedent etc.</li> <li>(2) The heir's current original Household Certificate with detailed narrative.</li> <li>(3) Inheritance tree diagram.</li> <li>(4) The heir's original identification.</li> </ol> </li> <li>3. If the applicant is an adult, it shall prepare the following supporting documents in addition to submitting the above documents:             <ol style="list-style-type: none"> <li>(1) If the applicant submits the request at the TWSE: an original of its I.D. card.</li> <li>(2) If the applicant engages another to submit the request at the TWSE on its behalf: an original of the fiduciary's own and the principal's original I.D. card and the power of attorney.</li> <li>(3) If the applicant submits the request in person at the securities broker to receive information by mail: a photocopy of the applicant's I.D. card (confirmed authentic upon verification by the securities broker) and certificate.</li> </ol> </li> <li>4. If the applicant is a minor, a person declared by a court to be under guardianship, a person subject to a court order for the commencement of assistantship, or an overseas Chinese, foreigner or Mainland individual, the documents for verification to accompany the three types of request, namely a request submitted in person at the TWSE, a request through another person at the TWSE, and a request submitted in person at the securities broker to receive information by mail, are respectively governed by Article 3, paragraphs 1 and 2, subparagraphs 2, 3 and 4 and paragraph 3, subparagraph 4, items 2, 3 and 4, etc. of the Taiwan Stock Exchange Corporation Procedures for Investors to Request Account or Transaction Information at the Centralized Securities Exchange Market.</li> </ol>
