- (4) Way: We will collect, process, and use your personal data digitally or in paper form
- 4. Rights of the data subject and way of exercising the rights:
 - You may exercise your data subject rights in personal data online, by telephone or in person at the TWSE, including the right to make an inquiry and to review; request a copy; request supplementation or correction. If you need to request the cessation of collection, processing or use, or request erasure, an application must be made in person at or in writing to the TWSE.
