For each request only for account opening information, a handling fee and computer processing fee of TWD 300 is charged per request per individual.</li> <li>2. For each request only for transaction information, or for both account opening and transaction information, a handling fee and computer processing fee of TWD 500 is charged per request per individual.</li> <li>3. A request made in person by an applicant who is 65 years old or above for the applicant's own account opening or transaction information to the TWSE is free of charge.</li> <li>4.
